Dear Art Outside Exhibitor:

Thank you for participating in the 2023 Schlafly Art Outside alternative art fair! Art Outside celebrates all things local and we couldn't be more excited to have you participate. As a reminder, Art Outside hours are:

- Friday, September 8th, 2023 from 5pm-9pm
- Saturday, September 9th, 2023 from 11am-9pm
- Sunday, September 10th, 2023 from 11am-4pm

Please read through the following information carefully. <u>Pay close attention to 'Check-In & Set-Up', as this is</u> where most confusion and frustration can be avoided if followed as outlined.



CHECK-IN PROCESS

The 2023 Schlafly Art Outside Festival will take place in Maplewood, Missouri at Schlafly Bottleworks 7260 Southwest Ave, St. Louis, MO 63143

- **A.** Enter the fairgrounds from the <u>East end of Southwest Ave. near Bellevue</u> (there is a red State Farm Insurance sign on the opposite corner).
- **B.** Check-in at the information tent when you arrive to receive:
 - o Directions/Guidance to Booth Location
 - o Exhibitor Badge (Please keep with you throughout the weekend)
 - Voucher Card
 - o "Reminders" Cheat Sheet



BOOTH SET-UP

- A. All Exhibitors must unload and set up between 10am and 3pm on Friday, September 8th. Set up will be broken down into sections, depending on where your booth is located. <u>This is the window</u> when your car can be on the lot to unload. If you need more time to set up, you are welcome to park elsewhere and cart in your items. However, your car can only come on the lot during these assigned windows. - **B.** Vehicle Access:
 - Enter the fairgrounds from the East end of Southwest Ave near Bellevue.
 - Artists are to bring one vehicle on the lot at a time & only keep it there to unload.
 - Once on lot, please quickly UNLOAD ONLY. Then you should find a place to park and come back to set-up.
 - Artists will not be allowed to leave cars on the lot while setting up their booths.
 - Artists MAY NOT USE the lots across from Schlafly Bottleworks for loading/unloading. You will be asked to move by us or those business and possibly towed at your expense.
- C. Please Note:
 - You MUST arrive within your allotted hour to guarantee prompt car access on the lot.
 - o Artists will not be allowed to enter or remain on the lot prior to their designated window time.
 - No exhibitors will be allowed to enter the lot or street to unload and set up before 10:00am or after 3:00pm.
 - We encourage you to bring another person to help unload your vehicle in a timely manner.



TENT REQUIREMENTS

- A. Signage:
 - Exhibitors may display signage within their booth space.
- **B.** Tent Specifics
 - Tents must be a white 10' x 10' tent with four sides so that it can be secured on Friday and Saturday night.
 - Each booth is required to have four tent weights WEIGHING AT LEAST 50LBS EACH (no stakes allowed)
 - Artists are responsible for installation and breakdown of own booth.
 - o Artist must provide own tents, weights, displays, walls for hanging art, and lighting.
- **C.** Inspections:
 - Tent inspections will begin at 4pm.
 - Booths will not be allowed to open if they do not have the below requirements:
 - Four (4) tent weights, weighing at least 50lbs each
 - Weights must be properly and securely tied to tent legs
 - No staking of tents allowed
- **D.** Lighting:
 - One (1) electrical outlet per booth space will be provided.
 - Exhibitors are required to use LED lightbulbs, registers/credit card machines only
 - Exhibitors are responsible for providing lighting, extension cords, power strips, clip lights, etc.


SALES & TAX INFORMATION

- **A.** Missouri statutes require that any business or person making retail sales in the State of Missouri must collect sales tax. All exhibitors are required to collect and report tax on merchandise sold at the fair.
- **B.** Upon check-in you will receive the Missouri Tax Report forms and a sales tax chart.
 - Art Outside is required to provide the Missouri Department of Revenue the names and addresses of all participants of the fair.
 - Your tax report and payment are due to the State of Missouri by the date printed on your Missouri Tax Report form.

PARKING

- **A.** Only one vehicle per exhibitor will be allowed on the lot to unload/load (entrance noted by red star and arrow on picture below).
- **B.** Artists MAY NOT PARK in the lots across from Schlafly Bottleworks. Your car will be towed at owner's expense if you park in this area.
- **C.** Artists MAY NOT PARK in the lots across from Schlafly Bottleworks when LOADING/UNLOADING. Your car will be towed at owner's expense if you park in this area.
- D. Public Parking Options
 - Marietta Lot located at Marshall & Marietta, South of Manchester (see large green box below)
 - Bellevue Lot located at corner of Bellevue & Manchester (see smaller green box below)
 - Street Parking (Please be respectful of our neighbors)



Please check-in and enter at the east entrance on Southwest Avenue.



EVENT SERVICES

- A. Security
 - Maplewood Police will be monitoring the lot & Southwest Ave. from 10pm-8am both Friday and Saturday nights.
 - If you have concerns about the safety of your artwork, we suggest you take valuable pieces home. While we will have security, The Saint Louis Brewery LLC (Schlafly Beer) is not responsible for theft or damage of booths/work.
- B. Food & Beverage
 - All Artists will receive (2) two voucher cards one for the artist and 1 guest.
 - Voucher cards are only redeemable at outside food/beverage tents during festival hours.
 - Four (4) ¹/₂ price meals
 - Eight (8) free beer/soda/water
- C. Prizes
 - \circ $\;$ The art fair is not juried this year. There will be no prizes awarded.


BOOTH BREAKDOWN

- **A.** The fair will close promptly at 4:00pm on Sunday with staff encouraging visitors to leave the premises so tear-down can begin.
- B. Exhibitors may not tear down before the festival ends at 4:00 pm on Sunday.
- **C.** We will allow as many vehicles on the lot as we deem safe at the time. While we understand that everyone will be tired and eager to vacate the premises, please exercise patience and caution and follow the directions of traffic staff and the teardown coordinators.
- D. Exhibitors must have booth completely broken down on off the street/lot by 7:00pm on Sunday.
- E. Exhibitors are responsible for clean up of all booth displays, including the removal of trash.
 - Please do not leave zip ties, rope, tape, signage, or any other trash on the lot or street
 - o If trash is left in your booth area, we will not consider you an option for future Art Outside.
